This release and waiver of liability executed on _____ (date) by _____ (volunteer) releases Lil' Rascals Wildlife Rehabilitation (LRWR), a nonprofit corporation organized and existing under the laws of the State of Maine, and each of its directors, officers, employees and agents harmless from liability for any and all actions, claims, damages, disabilities, liabilities, and expense of any type or nature that may arise due to my activities as a volunteer. The volunteer desires to provide volunteer services for the nonprofit and engage in activities related to serving as a volunteer.

Volunteer understands that the scope of the relationship with Lil' Rascals Wildlife Rehabilitation is limited to a volunteer position and that no compensation is expected in return for services provided by the volunteer. LRWR will not provide any benefits traditionally associated with employment and the volunteer is responsible for their own insurance coverage in the event of personal injury or illness as a result of volunteering with LRWR.

1. Waiver and release: I, the volunteer, release and forever discharge and hold harmless LRWR and its successors and assigns from any liability, claims, and demands of any nature, either on law or in equity, which may arise or may hereafter arise from services I provide to LRWR I understand and acknowledge that this release discharges LRWR from any liability or claim that I have against LRWR with respect to bodily injury, personal injury, illness, death or property damage that may result from services I provide to LRWR or occurring while I am volunteer services.
2. Insurance: I understand that LRWR does not hold any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of LRWR beyond what may be offered freely by LRWR in the event of injury or medical expenses incurred by me.
3. Medical treatment: I hereby release and forever discharge LRWR from any claim whatsoever which arises or may hereafter arise on account of any first aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with LRWR.
4. Assumption of risk: I understand that the services I provide to LRWR may include activities that are hazardous to me including, but not limited, to inherently dangerous activities. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and release LRWR from all liability.
5. Photographic release: I grant and convey to LRWR all right, title, and interest in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by LRWR in connection with my providing volunteer services to LRWR.
6. Other: As a volunteer I expressly agree that this release is intended to be a broad and inclusive as permitted by the State of Maine and that this release shall be governed by and interpreted in accordance with the laws of the State of Maine. I agree that in the event that any clause or provision within this release is deemed invalid, the enforceability of the remaining provisions of this release shall not be affected.
